## A. High School ASB Report

ASB President, Robert Vasquez reported that the volleyball team made CIF playoffs, but lost in the second round. The football team won Coast Valley League champions and will play their first playoff game on November 11<sup>th</sup>. Basketball teams have started practice. Homecoming week went well. There are four couples competing for Homecoming King and Queen. The vote will happen next week during the Pep Rally, with the ceremony to be held after the football game on November 11<sup>th</sup>. The Pumpkin Patch was a success, with the elementary school students coming at different times of the day to enjoy face painting, pumpkin picking, bounce house, playing games and eating food.

## B. High School Athletics Report

Athletic Director, Biff Charlton reported that the volleyball team ended the season as the third place team in Coast Valley League, qualifying for a CIF-SS wild card spot. The football team won their 7<sup>th</sup> consecutive Coast Valley League championship, with their first CIF-SS playoff game against Trona on Friday, November 11<sup>th</sup>. Basketball practice is under way with full schedules for both boys and girls varsity teams. #### A. Elementary School ASB Report
